HAMOR, CITY MAYOR, SORSOGON CITY TO CREATE AN INTER-AGENCY TASKFORCE THAT WILL CONDUCT MONITORING AND ASSESSMENT OF THE DEVELOPMENTS INTRODUCED AND ERECTED AT THE SORSOGON CITY ROMPEOLAS LOCATED AT BARANGAY TALISAY, WEST DISTRICT, SORSOGON CITY

WHEREAS, it is the mandate for the local government unit to exercise the powers expressly granted, those necessarily implied therefrom, as well as the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Sorsogon City Rompeolas is considered as one of the commonly known tourist destinations in the City of Sorsogon after introducing numerous improvements and developments therein;
