RESOLUTION CONCURRING THE APPOINTMENT OF ATTY. MARK GERALD D. GUIRINDOLA AS CITY ADMINISTRATOR OF THE CITY GOVERNMENT OF SORSOGON.

WHEREAS, as provided under section 454 (d), RA 7160, heads of the departments shall be appointed by the City Mayor with the concurrence of the majority of all the members of the Sangguniang Panlungsod subject to civil service laws, rules and regulations wherein the Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise, the same shall be deemed confirmed;

**WHEREAS,** Article II, Section 9 of Republic Act 8806, otherwise known as the Charter of the City of Sorsogon identifies the position of City Administrator as one of the City Officials among other positions;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> Council deemed it necessary to concur the appointment of Atty. Mark Gerald D. Guirindola as the City Administrator of the City of Sorsogon;

NOW THEREFORE, on motion of City Councilor Nestor J. Baldon, duly seconded by the City Councilor Erwin J. Duana, resolve as it is hereby resolved to concur the appointment of Atty. Mark Gerald D. Guirindola as City Administrator of the City Government of Sorsogon;
