### **RESOLUTION APPROVING THE APPLICATIONS FOR NEW TRICYCLE FRANCHISE**

**WHEREAS**, Sec. 458 (3) (vi) of RA 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod, subject to the guidelines prescribed by the Department of Transportation and Communications, has the power to regulate the operation of tricycles and grant franchise for the operation thereof within the territorial jurisdiction of the city;

**WHEREAS**, in conformity with Sangguniang Panlungsod Resolution Nos. 278 and 428, all Series of 2018 approved by the 6<sup>th</sup> City Council on September 4, 2018 and December 11, 2018 respectively, the herein applicants herein applied for the issuance of Tricycle Operation Franchise;

**WHEREAS**, a positive impact on the said legislative measure was apparent in view of the evident conformity of tricycle operators who personally appeared before the Office of the Secretary to the Sangguniang Panlungsod and complied with the requirement set forth by the resolution and of the City Permits and Licensing Section;

**WHEREAS**, for clarification purposes, the herein resolution to be issued per tricycle franchise applicant shall be a **CONDITION PRECEDENT** in the registration of motorcycles;
