RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES- NATIONAL SEAWEED TECHNOLOGY DEVELOPMENT CENTER (BFAR-NSTDC) RELATIVE TO THE PARTNERSHIP IN THE PROVISION OF MEDICAL AND DENTAL SERVICES, HEALTH EDUCATION AND COUNSELLING.

WHEREAS, among the items deliberated during the January 21, 2020 Regular Session of the 7th City Council is the letter-request from the Chief Executive requesting for a passage of a resolution authorizing the same to enter into a Memorandum of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources- National Seaweed Technology Development Center (BFAR-NSTDC) relative to the partnership in the provision of medical and dental services, health education and counselling;

WHEREAS, the City Government of Sorsogon welcomes every opportunity to partner with government and non-government entities in the implementation of worthy and viable projects and activities designed to improve the economic and social well-being of its constituents;
