RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ALLOCATE FUNDS FOR THE REPAIR AND REHABILITATION OF THE OFFICE OF THE SENIOR CITIZEN AFFAIRS (OSCA) AND THE COMPLETION OF THE CONSTRUCTION OF SORSOGON CITY SENIOR CITIZEN FEDERATION CENTER LOCATED AT THE CITY HALL COMPLEX CHARGEABLE TO ANY AVAILABLE FUND

WHEREAS, the constitution of the Republic of the Philippines provides that it is a declared policy of the state to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide social service, promote full employment, a rising standard of living and an improved quality of life;

WHEREAS, it is further declared that the state shall provide social justice in all phases of national development and that the state values the dignity of every human person and guarantee full respect for human rights;

**WHEREAS,** it is the duty of the city Government of Sorsogon to give full support to the elderly and their full participation in the society considering that senior citizens are integral part of our community;

**WHEREAS,** the Office of the Senior Citizen Affairs of the City of Sorsogon had been constructed and realized in the 1<sup>st</sup> semester of 2015 and occupied last August 3, 2015 through the funding and support for its construction of then Vice-President Jejomar Binay allocating the amount of Two Million Pesos;

WHEREAS, the OSCA Office also serves as the office of the Sorsogon City Senior Citizen Federation Center in which their officers and members also used for their meeting and other purposes;

**WHEREAS,** in connection with these there is a need to allocate funds for the concerns of the Senior Citizens of this city;

NOW THEREFORE, on motion of Hon. Erwin J. Duana, duly seconded by Hon. Franco Eric O. Ravanilla, resolve, as it is hereby resolved to respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to allocate funds for the repair and rehabilitation of the Office of the Senior Citizen Affairs (OSCA) and the completion of the construction of Sorsogon City Senior Citizen Federation Center located at the City Hall Complex chargeable to any available fund;
