RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF AN ULUTAN (DAYTIME) AND 3 COCK DERBY CALLED KASANGGAYAHAN CUP (NIGHT TIME) ON FEBRUARY 8, 2020 AT THE SORSOGON CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the January 21, 2020 Regular Session of the 7th City Council the letter-request from Mr. Ramon L. Dichoso II, President, Alpha Kappa Rho Cobra Chapter, requesting to conduct an ulutan (day time) and 3 cock derby called Kasanggayahan Cup (night time) on February 8, 2020 at the at the Sorsogon Central Cockpit Arena located at Barangay Bibincahan, East District, Sorsogon City;

WHEREAS, as reflected in the request, it is stated that portion of the proceeds will be donated to charitable institutions;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement

through the owner of the cockpit and shall be given to identified charitable institutions in the City of Sorsogon and that the party shall faithfully comply therewith;

WHEREAS, pursuant to existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the city;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of an ulutan (day time) and 3 cock derby called Kasanggayahan Cup (night time) on February 8, 2020 at the at the Sorsogon Central Cockpit Arena located at Barangay Bibincahan, East District, Sorsogon City;

NOW THEREFORE, on motion of Hon. Nestor J. Baldon, duly seconded by Hon. Joven G. Laura, resolved as it is hereby resolve to approve and authorize the conduct of an ulutan (day time) and 3 cock derby called Kasanggayahan Cup (night time) on February 8, 2020 at the Sorsogon Central Cockpit Arena located at Barangay Bibincahan, East District, Sorsogon City;

RESOLVED FURTHER, that fees and charges appurtenant thereto shall be paid to the City Treasurer's Office prior to the conduct of the activity;
