RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY AND HON. MARK ERIC C. DIONEDA, CITY VICE MAYOR TO ENTER INTO CONTRACT WITH THE NEWLY-HIRED JOB ORDERS OF EXECUTIVE AND LEGISLATIVE DEPARTMENT RESPECTIVELY IN THE CITY OF SORSOGON

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 mandates the local government unit to exercise the powers expressly granted, those necessarily implied therefrom, as well as the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the city government of Sorsogon engages and hires contractual employees to augment the manpower necessary for the efficient delivery of basic services to the constituents of the city;

WHEREAS, the Sangguniang Panlungsod through a resolution has the power to authorize the City Mayor and the City Vice Mayor to enter into contracts with the newlyhired job order employees of their departments;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th city council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City and Hon. Mark Eric C. Dioneda, City Vice Mayor to enter into contract with the newly-hired job orders of executive and legislative department respectively in the City of Sorsogon;

NOW THEREFORE, on motion of Hon. Nestor J. Baldon, duly seconded by Hon. Rebecca Aquino, resolve, as it is hereby resolved to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City and Hon. Mark Eric C. Dioneda, City Vice Mayor to enter into contract with the newly-hired job orders of executive and legislative department respectively in the City of Sorsogon.
