RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE SORSOGON CITY WATER DISTRICT (SCWD) HEREIN REPRESENTED BY ITS INTERIM GENERAL MANAGER ENGR. EDUARDO P. TAJEDA RELATIVE TO THE TEMPORARY USE OF THE TRAINING CENTER SITUATED AT THE 2<sup>ND</sup> FLOOR OF CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFFICE (CDRRMO) BUILDING, CITY HALL COMPLEX, DIVERSION ROAD, CABID-AN, EAST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the January 28, 2020 Regular Session of the 7<sup>th</sup> City Council is the letter-request from the Chief Executive requesting for a passage of a resolution authorizing the same to enter into a Memorandum of Agreement (MOA) with the Sorsogon City Water District (SCWD) herein represented by its Interim General Manager Engr. Eduardo P. Tajeda relative to the temporary use of the training center situated at the 2<sup>nd</sup> Floor Of CDRRMO Building, City Hall Complex, Diversion Road, Cabid-An, East District, Sorsogon City;

**WHEREAS,** the Sorsogon City Water District (SCWD) permanent office is currently under construction, thus, their personnel is in need of a temporary office where they can perform their day-to-day affairs;

**WHEREAS,** the City Government of Sorsogon has an existing Training Center located at the 2<sup>nd</sup> Floor of the City Disaster Risk Reduction and Management Building within the City Hall Compound;

**WHEREAS,** the Sorsogon City Water District (SCWD) asked permission to occupy the said Training Center to serve as their temporary office for all their transactions until the repair of their edifice is complete, provided further that the usage thereof is only limited employees of the Sorsogon City Water District;

**WHEREAS,** attached to the letter request is a copy of Memorandum of Agreement (MOA) for further perusal of the 7<sup>th</sup> City Council;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with the Sorsogon City Water District (SCWD) herein represented by its Interim General Manager Engr. Eduardo P. Tajeda relative to the temporary use of the training center situated at the 2<sup>nd</sup> Floor Of CDRRMO Building, City Hall Complex, Diversion Road, Cabid-an, East District, Sorsogon City;

**NOW THEREFORE,** on motion of **Hon. Mary Ellen D. Jamisola**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E.
