**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution most respectfully requesting Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to open a separate bank account intended for the 5% Calamity Fund of the City of Sorsogon;
