RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH MINES AND GEOSCIENCES BUREAU, REGIONAL OFFICE NO. V REPRESENTED BY GUILLERMO A. MOLINA, JR. IV, OIC, OFFICE OF THE REGIONAL DIRECTOR, FOR THE PRODUCTION, SHARING AND TRANSFER OF HAZARD MAPS FOR THE CITY OF SORSOGON.

WHEREAS, on July 16, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice-Mayor and the Honorable Members of the Sangguniang Panlungsod requesting for the passage of a resolution authorizing the local chief executive to enter into a Memorandum of Understanding (MOU) with Mines and Geosciences Bureau, Regional Office No. V represented by Guillermo A. Molina, Jr. IV, OIC, Office of the Regional Director, for the production, sharing and transfer of Hazard Maps for the City of Sorsogon;

WHEREAS, the National Geohazard Mapping and Assessment Program of the Mines and Geosciences Bureau generate the 1:10,000 Scale Flood and Landslide Susceptibility Maps using a Geographic Information System or GIS;

WHEREAS, on its 3rd phase of implementation, 1:10,000 Scale Physical and Socio-Economic Vulnerability and Risk Maps for Flood and Landslides Hazards for the eleven (11) urban barangays in the City of Sorsogon has been generated along with the production of Geohazard and Risk – Enhanced Assessment Tool (GREAT) that can be used for Vulnerability and Risk Mapping for population and physical structures for the rest of the barangays in the city;

**WHEREAS,** attached to the letter request is a copy of Memorandum of Understanding (MOU) for further perusal of the 7<sup>th</sup> City Council;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Understanding (MOU) with Mines and Geosciences Bureau, Regional Office No. V represented by Guillermo A. Molina, Jr. IV, OIC, Office of the Regional Director, for the production, sharing and transfer of Hazard Maps for the City of Sorsogon;

NOW THEREFORE, on incidental motion of Hon. Nestor J. Baldon, duly seconded by Hon. Danilo A. Deladia, resolved as it is hereby resolve to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Understanding (MOU) with Mines and Geosciences Bureau, Regional Office No. V represented by Guillermo A. Molina, Jr. IV, OIC, Office of the Regional Director, for the production, sharing and transfer of Hazard Maps for the City of Sorsogon;
