RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO EXECUTE A DEED OF CONDITIONAL DONATION IN FAVOR OF THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) REPRESENTED BY ATTY. RAMMEL L. BONAVENTE, JAIL CHIEF INSPECTOR, SORSOGON CITY DISTRICT JAIL, COVERING LOT 2-D-4-11-B UNDER TCT NO. 083-2019000349

WHEREAS, the Bureau of Jail Management and Penology (BJMP) thru a letter dated August 9, 2019 addressed to the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City appealed for the donation of a parcel of land adjacent to the lot which they presently occupy within the City Hall Complex;

WHEREAS, the appeal/request was referred to the Committees on City Properties and Land Use whereby a committee hearing was conducted on November 26, 2020 for the purpose with the presence of the concerned parties and representatives;

WHEREAS, the BJMP is a recipient/ donee of a Three Thousand Five Hundred (3,500) Square meter portion of the Five Thousand Seven Hundred (5,700) Square Meter lot under a Deed of Conditional Donation executed by and between the then City Mayor Sally A. Lee relative to the LGU's prior commitment to various government agencies for the construction of their offices within the vicinity of the City Hall, for the purpose of public convenience;

WHEREAS, the BJMP was prompted to request and appeal for the donation of the remaining 2,200 square meters adjacent to the present building of the BJMP which is intended for the construction of additional buildings so as to accommodate the increasing number of inmates thereof.

WHEREAS, one of the recommendations of the committee was for the BJMP to submit a Draft Deed of Donation wherein the agency faithfully and promptly complied.

NOW THEREFORE, on motion of **Hon. Mary Ellen D. Jamisola**, duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to execute a Deed of Conditional Donation in favor of the Bureau of Jail Management and Penology (BJMP) represented by Atty. Rammel Bonavente, Jail Chief Inspector, Sorsogon City District Jail, Covering Lot 2-D-4-11-B Under TCT No. 083-2019000349.
