RESOLUTION APPROVING AND ADOPTING THE REPROGRAMMED LOCAL DISASTER RISK REDUCTION MANAGEMENT PLAN (LDRRMP) AND LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP) FOR CY 2019, SPECIAL TRUST FUND BALANCE (2018) AND SPECIAL TRUST FUND BALANCE (2017) OF THE CITY OF SORSOGON

WHEREAS, on June 15, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to City Vice Mayor Mark Eric C. Dioneda respectfully requesting for the approval and adoption of the hereunder plans duly submitted by the Sorsogon City Disaster Risk Reduction Management Council, to with;

- 1. Local Disaster Risk Reduction Management Plan (LDRRMP) and Local Disaster Risk Reduction Management Fund Investment Plan (LDRRMFIP) for calendar year 2019;
- Local Disaster Risk Reduction Management Plan (LDRRMP) and Local Disaster Risk Reduction Management Fund Investment Plan (LDRRMFIP) for special Trust Fund Balance (2018);
- 3. Local Disaster Risk Reduction Management Plan (LDRRMP) and Local Disaster Risk Reduction Management Fund Investment Plan (LDRRMFIP) for special Trust Fund Balance (2017); and
- 4. CDRRMC Resolution No. 003, 2019.

WHEREAS, the Local Chief Executive further certified on the urgency of the passage of the requested resolution from the 7th City Council being a part of the City Disaster Preparedness and Response (DPR) Program;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution approving and adopting the reprogrammed Local Disaster Risk Reduction Management Plan (LDRRMP) and Local Disaster Risk Reduction Management Fund Investment Plan (LDRRMFIP) for CY 2019, Special Trust Fund Balance (2018) and Special Trust Fund Balance (2017) of the City of Sorsogon;
