**RESOLUTION GRANTING MR. CHRISTOPHER D. TAN OF MALALAG, DAVAO DEL SUR PROVISIONAL AUTHORITY TO ESTABLISH A TECHNOLOGY DEMONSTRATION PROJECT ON MILKFISH CULTURE IN THE MARITIME ZONE OF BACON DISTRICT, SORSOGON CITY SUBJECT TO THE REQUIREMENTS SET FORTH BY LGU-SORSOGON CITY AND OTHER LINE AGENCIES**

**WHEREAS,** On July 4, 2019 a letter from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice-Mayor and the Honorable Members of the Sangguniang Panlungsod requesting for the passage of a resolution granting Mr. Christopher D. Tan Of Malalag, Davao Del Sur provisional authority to establish a Technology Demonstration Project on Milkfish Culture in the Maritime Zone of Bacon District, Sorsogon City subject to the requirements set forth by LGU-Sorsogon City and other line agencies;

**WHEREAS**, the letter-request was among the items deliberated during the July 9, 2019 Regular Session and thereafter referred to the Committee on Agriculture and Food;


