RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF THREE (3) COCK ELIMINATION SPONSORED BY CAMARINES GAMEFOWL BREEDERS ASSOCIATION (CGBA) ON FEBRUARY 15, 2020 AND FEBRUARY 22, 2020 AT THE SORSOGON CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the January 28, 2020 Regular Session of the 7th City Council is Committee Report No. 012, Series of 2020 of the Committee on Games and Amusement dated January 17, 2020 RE: letter-request from Mr. Aladin Caubang, dated January 6, 2020 for the conduct of three (3) cock elimination sponsored by Camarines Gamefowl Breeders Association (CGBA) on February 15, 2020 and February 22, 2020 at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

WHEREAS, as reflected in the request, it is stated that portion of the proceeds will be donated to charitable institutions;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to identified charitable institutions in the City of Sorsogon and that the party shall faithfully comply therewith;

WHEREAS, pursuant to existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the city;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of three (3) Cock Elimination sponsored by Camarines Gamefowl Breeders Association (CGBA) on February 14, 2020 and February 22, 2020 at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to approve and authorize the conduct of three (3) Cock Elimination sponsored by Camarines Gamefowl Breeders Association (CGBA) on February 14, 2020 and February 22, 2020 at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;
