RESOLUTION FAVORABLY ENDORSING THE PROPOSED DEVELOPMENT AND IMPROVEMENT OF PUBLIC PARKS AT CITY HALL GROUNDS AND PART OF THE APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM AND 2019 ANNUAL INVESTMENT PLAN OF THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the January 28, 2020 Regular Session of the 7th City Council is the letter from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, dated January 10, 2020, requesting for a passage of resolution favorably endorsing the proposed Development and Improvement of Public Parks at City Hall Grounds and Part of the Approved Local Development Investment Program and 2019 Annual Investment Plan of the City of Sorsogon.

WHEREAS, the City Government of Sorsogon has been allotted with Fifteen Million Four Hundred Fifty One Thousand Four Hundred Eighteen (P15,451,418.00) Pesos under the Fiscal Year 2019 Local Government Support Fund- Assistance to Cities (LGSF-AC) that will be used to enhance

existing or develop new public open spaces in publicly owned lands that are free and accessible to the general public with SARO-2019-LGRCB-19-001354 dated September 17, 2019;

WHEREAS, in order to release the corresponding Notice of Cash Allocation (NCA), we are required to submit documents under the Local Budget Circular (LBC) No. 20;

NOW THEREFORE, on motion of Hon. Franco Eric O. Ravanilla, duly seconded by Hon. Nestor J. Baldon, resolve as it is hereby resolved to favorably endorse the proposed Development and Improvement of Public Parks at City Hall Grounds and Part of the Approved Local Development Investment Program and 2019 Annual Investment Plan of the City of Sorsogon.
