RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THRU MR. CHRISTIAN D. SANCHEZ, MARKET SUPERVISOR TO CREATE THE SORSOGON CITY TASK FORCE TIMBANGAN THAT WILL CONDUCT MONITORING OF WEIGHING SCALES IN THE PUBLIC MARKETS IN THE CITY OF SORSOGON

WHEREAS, there are numerous complaints from the general public regarding the anomalous practice of some vendors in the public markets by using inaccurate weighing scale;

WHEREAS, weighing the products in the “Timbangan ng Bayan” after buying and weighing by the vendors was discovered inaccurate or less than the value of the goods being bought thereby;

WHEREAS, “Timbangan ng Bayan” is the only protection of the general public against unscrupulous or deceitful conducts of some vendors in the public market and therefore shall all times be protected and maintained;

WHEREAS, in order to provide the public a reliable, sealed and calibrated weighing scales, the Sorsogon City Task Force Timbangan shall be created for the purpose;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, **enhance economic prosperity and social justice**, maintain peace and order and **preserve the comfort and convenience of their inhabitants**;

NOW THEREFORE, on motion of **Hon. Rebecca D. Aquino**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru Mr. Christian D. Sanchez, Market Supervisor to create the Sorsogon City Task Force Timbangan that will conduct monitoring of weighing scales in the public markets in the City of Sorsogon;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
