**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO CONDITIONALLY DONATE FIVE HUNDRED (500) SQUARE METERS PARCEL OF LAND WITHIN THE CITY HALL COMPOUND IN FAVOR OF THE PHILIPPINE NATIONAL RED CROSS-SORSOGON CHAPTER FOR THE CONSTRUCTION OF ITS BUILDING**

**WHEREAS**, among the items deliberated during the February 4, 2020 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP dated July 29, 2019 requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to conditionally donate five hundred (500)

square meters parcel of land within the City Hall Compound in favor of the Philippine National Red Cross-Sorsogon Chapter for the construction of its building;

**WHEREAS**, the committees on Government Properties and Land Use, Urban Planning and Housing conducted joint committee hearing for the purpose therein obtained the importance of the request being valid and meritorious and thereby recommended for its approval in the plenary in session;

**WHEREAS**, the Philippine National Red Cross- Sorsogon Chapter is among our strongest partners in the delivery of health related services to our people specifically in terms of bloodletting activities and blood donation among others;

**WHEREAS**, there have been a considerable number of related events organized by different sectors over the years, nonetheless the demands for blood by hospitals, dialysis centers and other medical facilities are not satisfied;

**NOW THEREFORE**, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to conditionally donate five hundred (500) square meters parcel of land within the City Hall Compound in favor of the Philippine National Red Cross-Sorsogon Chapter for the construction of its building;
