RESOLUTION ENACTING AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 01, CALENDAR YEAR 2020 OF THE CITY GOVERNMENT OF SORSOGON INVOLVING AN AMOUNT OF THIRTY MILLION THREE HUNDRED SEVENTY SEVEN THOUSAND ONE HUNDRED FORTY TWO & 28/100 (₱30,377,142.28) PESOS.

WHEREAS, as mandated by law and under the existing Internal Rules, Annual Performance, Supplemental Budget/s and any appropriation of funds within the jurisdiction of the City of Sorsogon, shall pass before the Sangguniang Panlungsod for further review and approval;

WHEREAS, the statement of supplemental appropriation embodied and incorporated in Supplemental Budget No. 01, Calendar Year 2020 of the City Government of Sorsogon was deemed legal in compliance with accounting and auditing rules;

WHEREAS, after thorough deliberations on the statement of supplemental appropriations of Supplemental Budget No. 01, Calendar Year 2020, the 7th City Council deemed it necessary to approve the same;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla,** duly seconded by **City Councilor Rebecca D. Aquino,** the 7th City Council do hereby approve and adopt Supplemental Budget No. 01, Calendar Year 2020 of the City Government of Sorsogon and be it resolve as it is hereby done to enact;

BE IT ORDAINED BY THE 7TH CITY COUNCIL THAT:
