WHEREAS, it is of common knowledge that both Barangay Sampaloc and Barangay Sirangan had been a perennial host to informal settlers despite relentless efforts of national agencies and the Local Government Unit to effect and complete their relocation;

WHEREAS, these informal settlers who mostly belong to the marginalized and less privileged sectors would repudiate and assail programs on relocation mainly due to economic dislocation being that their livelihood is within the area aggravated by

additional expenses that maybe incurred by the family and likewise complicated by problems on water and electricity which are considered as basic necessities in life;

WHEREAS, high end tenements would provide the informal settlers decent homes of their own thereby putting an end to their prolonged dreams and plans of having their permanent houses and cast away their fears of being dislocated from their jobs and livelihood;


