WHEREAS, during the February 18, 2020 Regular Session of the 7th City Council, Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to Hon. Mark Eric C. Dioneda, City Vice – Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, SP Secretary dated February 12, 2020 requesting for the passage of a resolution endorsing the designation of Mr. William D. Dechavez as the Authorized Representative of the City Government of Sorsogon in all undertakings in relation to our Sister City Agreement with Sterling Heights, Michigan, USA;


