RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE PROVINCIAL GOVERNMENT OF SORSOGON REPRESENTED BY HON. FRANCIS JOSEPH G. ESCUDERO, GOVERNOR, PROVINCE OF SORSOGON RELATIVE TO THE IMPLEMENTATION OF THE UNIVERSAL HEALTH CARE PROGRAM.

WHEREAS, during the February 18, 2020 Regular Session of the 7th City Council, Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to Hon. Mark Eric C. Dioneda, City Vice – Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, SP Secretary dated February 12, 2020 requesting for the passage of a resolution authorizing the local chief executive to enter into a Memorandum of Understanding (MOU) with the Provincial Government of Sorsogon represented by Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon relative to the implementation of the Universal Health Care Program;

WHEREAS, Section 15 of the 1987 Constitution declares that "the state shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, Republic Act 11223 also known as the "Universal Health Care Act" and its Implementing Rules and Regulations states that the Local Government Unit shall oversee and coordinate the integration of health services for province-wide and city-wide health systems;

WHEREAS, healthcare service is one of the priority programs of the City Government of Sorsogon;

WHEREAS, attached to the letter is a copy of a draft Memorandum of Understanding (MOU) for further perusal of the 7th City Council;

NOW THEREFORE, on motion of Hon. Franco Eric O. Ravanilla, duly seconded by Hon. Mary Ellen D. Jamisola, resolved as it is hereby resolve to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Understanding (MOU) with the Provincial Government of Sorsogon represented by Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon relative to the implementation of the Universal Health Care Program;
