**RESOLUTION REQUIRING ALL TRICYCLE FRANCHISE HOLDERS WITH OLD FRANCHISE PLATE TO HAVE THEIR RESPECTIVE NEWLY ISSUED PLATE BEARING THE SAME PLATE NUMBER AT THE SP TRICYCLE FRANCHISING SECTION AND FAILURE TO COMPLY HEREWITH UNTIL MARCH 15, 2020 WILL SUBJECT THE FRANCHISE AND ITS UNIT FOR APPROPRIATE DISCIPLINARY ACTION APPLICABLE THERETO.**

**WHEREAS**, at present, there are still considerable number of new tricycle plates left at the SP Tricycle Franchising Section that are not yet secured by their respective tricycle franchise holders;

**WHEREAS**, it is the policy of the City of Sorsogon through the Sangguniang Panlungsod that all dilapidated and old franchise plate should be replaced with the new franchise plates which were purchased by the city government for the purpose;

**WHEREAS**, some tricycle franchise operators/holders deliberately refused or declined to replace their old franchise plate, purposely to avoid payment thereof;

**WHEREAS**, those tricycle franchise operators/holders who did not replace the old franchise plate with the prescribed new plate bearing the same plate number shall be required to comply the same until March 15, 2020;

**WHEREAS**, non-compliance of the herein requirement after March 15, 2020 will subject the franchise and its unit for appropriate action conferred upon by the Sorsogon City Tricycle Franchise Code;

**WHEREAS**, the tricycle franchise operators/holders will be allowed to pay the amount of the new tricycle plate during the renewal of their Motorized Tricycle Operation Permit (MTO);

**WHEREAS**, their Motorized Tricycle Operation Permit (MTO) shall be released only upon presentation of the corresponding receipt for payment thereof issued by the Office of the City Treasurer;

**WHEREAS**, the Sangguniang Panlungsod, by virtue of provisions under RA 7160, otherwise known as the Local Government Code of 1991, subject to the guidelines prescribed by the Department of Transportation and Communications has the power to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the city (RA 7160, Sec.458 (3)(vi));

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to pass a resolution requiring all tricycle franchise holders with old franchise plate to have their respective newly issued plate bearing the same plate number at the SP Tricycle Franchising Section and failure to comply herewith until March 15, 2020 will subject the franchise and its unit for appropriate disciplinary action applicable thereto;
