RESOLUTION ENDORSING THE SORSOGON CITY FOREST LAND USE PLAN (FLUP) (2018-2022) TO THE DENR – REGIONAL DIRECTOR.

WHEREAS, DENR-DILG Joint Memorandum Circular No. 01, Series of 1998 required the local government units to prepare their respective Forest Land Use Plan (FLUP) and integrate them into their Comprehensive Land Use Plan (CLUP) for more sustainable management of forests and forestlands;

WHEREAS, Forest Land Use Plan (FLUP) is an indispensable requirement for the Comprehensive Land Use Plan (CLUP) of the LGUs;

WHEREAS, the Forest Land Use Plan was formulated through the technical assistance of the DENR and by the World Bank under its Program for Forest II (PROFOR II) which included ecological services and valuation in the formulation of the FLUP;

WHEREAS, the FLUP has been duly reviewed by the DENR V through its Forest Management Bureau (FMB) and was approved by the City Development Council during its 4th Council Meeting held on October 18, 2018;


WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to pass a resolution endorsing the Sorsogon City Forest Land Use Plan (FLUP) (2018-2022) to the DENR – Regional Director;
