RESOLUTION ALLOWING THE OWNERS OF THE COCKPIT ARENAS IN THE CITY OF SORSOGON TO COLLECT ADDITIONAL FIVE (P5.00) PESOS FOR EVERY ENTRANCE FEE IN REGULAR SUNDAY COCKPIT OPERATION TO BE GIVEN TO CHARITABLE INSTITUTIONS IN THE CITY OF SORSOGON.

**WHEREAS**, the Home for the Aged is in financial constraint for their daily operation hence, they requested the Sangguniang Panlungsod and Mr. Rico R. Ortiz, the owner of the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, Sorsogon City to allocate five (P5.00) Pesos for every entrance fee at the said cockpit coliseum;

**WHEREAS**, the owner of the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, Sorsogon City is willing to support the request of the Home for the Aged and is willing to collect additional P5 for every entrance fee and the accumulated amount will be given every month to the latter and other similar charitable institutions;

**WHEREAS**, that the additional P5 for every entrance fee shall be collected in a regular Sunday cockfights only and this is applicable to all charitable institutions in the city and will be covered by an internal arrangement between the parties;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

**NOW THEREFORE,** on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to allow the owners of the cockpit arenas in the City of Sorsogon to collect additional five (p5.00) pesos for every entrance fee in regular Sunday cockpit operation to be given to charitable institutions in the City of Sorsogon;

**RESOLVED FURTHER,** that copies of this resolution be furnished to all concerned for their information and guidance.
