WHEREAS, the Sangguniang Panlungsod, Sorsogon City was furnished with the notice, receipt thereof of the Sangguniang Panlungsod dated February 20, 2020, from this Honorable Court vis a vis the application/motion for the release of the accused on recognizance as embodied in Republic Act 10389 under Criminal Case No. 2019-11059 For: FRUSTRATED MURDER;

WHEREAS, on occasion of the Regular Session of the City Council on March 3, 2020 after deliberations, the august body firmly believes that the applicants deserve compassion, being that they are indigents and anchored on the maxim that "those who have less in life must have more in law" and that they be released on recognizance to the custody of a qualified resident of Barangay Osiao, Bacon District, Sorsogon City or to any qualified resident of Sorsogon City, as the case maybe, pursuant to R.A. No. 10389, upon compliance of the requirements set forth thereunder;
