RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE 64 BARANGAY CAPTAINS OF THE CITY OF SORSOGON RELATIVE TO THE BARANGAY DEVELOPMENT PROGRAMS OF THE CITY GOVERNMENT

WHEREAS, on August 27, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod requested for the passage of a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with the 64 Barangay Captains of the City of Sorsogon relative to the Barangay Development Programs of the city government;

WHEREAS, the city government of Sorsogon will be implementing the Barangay Development Program for the 64 barangays in the City of Sorsogon funded under Item No. 1 – 1 (General Services – Barangay Development Program) of the 2019 20% Development Fund as City Aid;

WHEREAS, this program aims to help the various barangays in the city to implement and carry-out projects considered as most beneficial to their constituents and will commence on the 1st week of September 2019;

WHEREAS, attached to the letter request is a copy of Memorandum of Agreement (MOA) for further perusal of the 7th City Council;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into and sign a Memorandum of Agreement (MOA) with the 64 barangay captains of the City of Sorsogon relative to the Barangay Development Programs of the city government;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Erwin J. Duana**, resolved as it is hereby resolve to authorize Hon. Ma. Ester E. Hamor, City Mayor to enter into and sign a Memorandum of Agreement (MOA) with the 64 barangay captains of the City of Sorsogon relative to the Barangay Development Programs of the city government;
