**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM NG PAGKAKASUNDO (MEMORANDUM OF UNDERSTANDING) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES –RO5 (BFAR-RO5) REPRESENTED BY REGIONAL DIRECTOR NELSON B. BIEN D. F. TECH, RELATIVE TO THE GRANT OF ONE (1) UNIT 30 FOOTER FIBERGLASS (TWIN ENGINE) FROM THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR).**

**WHEREAS**, during the March 10, 2020 Regular Session of the 7<sup>th</sup> City Council, Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, SP Secretary dated March 3, 2020 requested for the passage of a resolution authorizing the Local Chief Executive to enter into a Memorandum ng Pagkakasundo (Memorandum of Understanding) with the Bureau of Fisheries and Aquatic Resources –RO5 (BFAR-RO5) represented by Regional Director Nelson B. Bien D. F.

Tech, relative to the grant of one (1) unit 30 footer fiberglass (twin engine) from the Bureau of Fisheries and Aquatic Resources (BFAR);

**WHEREAS**, Section 2 (d) of the Republic Act No. 10654 declares that “the provisions of such shall be enforced in all Philippine flagged fishing vessels operating in areas governed by a Regional Fisheries Management Organization (RFMO), in the high seas, or in waters of other coastal states.”;

**WHEREAS**, item (q), Section 65 of Republic Act 8550 also known as “An Act providing the development, management and conservation of the fisheries and aquatic resources, integrating all laws pertinent thereto and for other purposes” provides that the BFAR shall assist the LGU’s in developing their technical capability in the development, management, regulation, conservation and protection of the fishery resources;

**WHEREAS**, said boat shall be utilized by the local Bantay Dagat in the performance of their duties within the territorial seas of the City of Sorsogon;

**WHEREAS**, attached to the letter is a copy of a draft Memorandum ng Pagkakasundo (Memorandum of Understanding) for further perusal of the 7<sup>th</sup> City Council;

**NOW THEREFORE**, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to Enter Into a Memorandum ng Pagkakasundo (Memorandum Of Understanding) with the Bureau of Fisheries and Aquatic Resources – Ros (BFAR-ROS) represented by Regional Director Nelson B. Bien D. F. Tech relative to the grant of one (1) Unit 30 Footer Fiberglass (Twin Engine) from the Bureau of Fisheries and Aquatic Resources (BFAR).
