RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE ARMED FORCES OF THE PHILIPPINES 31ST INFANTRY (CHARGE) BATTALION REPRESENTED BY LTC ERIC H. CULVERA, BATTALION COMMANDER, RELATIVE TO THE IMMERSION PHASE OF THEIR COMMUNITY SUPPORT PROGRAM (CSP).

WHEREAS, during the March 10, 2020 Regular Session of the 7th City Council, Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, SP Secretary dated March 3, 2020 requested for the passage of a resolution authorizing the Local Chief Executive to enter into a Memorandum of Understanding (MOU) with the Armed Forces of the Philippines 31st Infantry (Charge) Battalion represented by LTC Eric H. Culvera, Battalion Commander, relative to the Immersion Phase of their Community Support Program (CSP).

WHEREAS, for the success of their deployment, the City Government shall be entering into a Memorandum of Understanding (MOU) with the 31st Infantry (Charge) Battalion wherein their mutual obligations are stipulated;
