**RESOLUTION URGING THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) PROVINCIAL FIELD OFFICE TO CLOSELY MONITOR PRICE MANIPULATION AND HOARDING OF BASIC AND ESSENTIAL COMMODITIES AMIDST THE DECLARATION OF THE PROVINCE UNDER STATE OF CALAMITY BY HON. FRANCIS JOSEPH G. ESCUDERO, GOVERNOR, PROVINCE OF SORSOGON DULY ADOPTED BY THE CITY GOVERNMENT OF SORSOGON THROUGH EXECUTIVE ORDER NO. 13, SERIES OF 2020 ISSUED BY THE HON. MA. ESTER E. HAMOR, CITY MAYOR IN RELATION TO THE COVID 19 PANDEMIC.**

**WHEREAS**, in the middle of global threat to humanity, "COVID 19" now tests human perseverance and unity manifested by unprecedented death tolls in China, Italy and other countries;

**WHEREAS**, following the principle of protecting the interest of vulnerable community in the city, especially when the daily source of living of marginal workers are disrupted in line of the present unavoidable circumstance, there is a need to safeguard our constituents against price manipulation and hoarding of basic and essential commodities;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> city council deemed it necessary to pass a resolution urging the Department of Trade and Industry (DTI) Provincial Field Office to closely monitor price manipulation and hoarding of basic and essential commodities amidst the declaration of the province under state of calamity by Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon duly adopted by the City Government of Sorsogon through Executive Order No. 13, series of 2020 issued by the Hon. Ma. Ester E. Hamor, City Mayor in relation to COVID 19 pandemic;

**NOW THEREFORE**, on motion of City Councilor **Franco Eric O. Ravanilla**, duly seconded by **Hon. Rebecca D.
