**RESOLUTION TEMPORARILY SUSPENDING THE STRICT IMPLEMENTATION OF PROHIBITING/BANNING THE ENTRY OF DELIVERY TRUCKS, VANS AND OTHER VEHICLES AT A SPECIFIED PERIOD OF TIME WITHIN THE COMMERCIAL DISTRICT OF SORSOGON CITY**

**WHEREAS**, there had been pressing and urgent concerns among the constituents in connection with the rigid implementation of the precautionary measures adopted by both the Provincial and City Governments which they foresee that it may cause adverse effects particularly on the delivery of basic and essential commodities;

**WHEREAS**, the relaxation of the implementation of the ordinance would likewise lessen and reduce economic dislocation particularly on the marginalized sector by providing them continuous source of livelihood;

**WHEREAS**, at this point in time due consideration shall be extended to the constituents and entrepreneurs particularly those who are engaged in the delivery of goods in the City of Sorsogon;

**NOW THEREFORE**, on motion of **City Councilor Ma. Teresa D. Perdigon**, duly seconded by **Hon. Rebecca D. Aquino** resolve as it is hereby resolved to temporarily suspend the strict implementation of prohibiting/banning the entry of delivery trucks, vans and other vehicles at a specified period of time within the commercial district of Sorsogon City.
