RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO PROVIDE MILK AND VITAMINS ASSISTANCE FOR ALL EIGHT (8) MONTHS INFANTS AND BELOW OF ALL LACTATING INDIGENT RESIDENT MOTHERS AND OF INDIGENT RESIDENT SOLO FATHERS IN THE CITY OF SORSOGON WHILE UNDER THE ENHANCED COMMUNITY QUARANTINE AMID PANDEMIC COVID 19

WHEREAS, on March 17, 2020, a memorandum order from the Office of the President placed the whole island of Luzon under enhanced community quarantine;

WHEREAS, among the pronouncements in the said memorandum is the stipulation for the enforcement of a lockdown and suspension of work in government and private agencies;

WHEREAS, Executive Order No. 12, Series of 202 from the Office of the City Mayor provides that residents of the City of Sorsogon are directed to stay indoors and abide the curfew ordinance for COVID-19 from 9:00 p.m. to 5:00 a.m.;

WHEREAS, due to such predicament and economic uncertainties, indigent resident non-lactating mothers and indigent solo fathers in the City of Sorsogon cannot provide for proper nutrition of their infants, particularly those eight (8) months and below, considering that they are dependent to milk and or liquid/ soft solid foods;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, **promote health and safety**, improve public morals, enhance economic prosperity and social justice, maintain peace and order and **preserve the comfort and convenience of their inhabitant**;

NOW THEREFORE, on motion of **City Councilor Jo Abegail C. Dioneda**, duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby resolved to respectfully request the Honorable Ma. Ester E. Hamor, City Mayor, Sorsogon City to provide milk and vitamins assistance for all eight (8) months infants and below of all lactating indigent resident mothers and of indigent resident solo fathers in the City of Sorsogon while under the enhanced community quarantine amid pandemic covid 19.

RESOLVED FURTHER, resolved further that copies of this resolution be furnished to all concerned for their information and guidance.


