**RESOLUTION ADOPTING EXECUTIVE ORDER NO. 14-2020 ISSUED BY THE HON. FRANCIS JOSEPH G. ESCUDERO, GOVERNOR, PROVINCE OF SORSOGON ORDERING THE SUSPENSION OF CLASSES IN ALL LEVELS OF PUBLIC AND PRIVATE SCHOOLS IN THE PROVINCE OF SORSOGON FOR A PERIOD OF THIRTY (30) DAYS BEGINNING MARCH 16, 2020 UP TO APRIL 15, 2020.**

**WHEREAS**, on March 15, 2020, the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon issued Executive Order No. 14-2020 ordering the Suspension of Classes in all levels of Public and Private Schools in the Province of Sorsogon for a period of thirty (30) days beginning March 16, 2020 up to April 15, 2020;

**WHEREAS**, the herein Executive Order of the Governor is in consonance with the Proclamation No. 922 dated March 08, 2020 issued by His Excellency Rodrigo Roa Duterte, President, Republic of the Philippines declaring a State of Public Health Emergency

throughout the Philippines due to COVID 19 and the imposition of additional measures to ensure the safety of the general public and lessen the possibility of spread of said disease;

**WHEREAS**, the Inter-Agency Task Force for the Management of Emerging Infectious Disease also issued Resolution No. 11, series of 2020 dated March 12, 2020 raising the Code Alert System for COVID-19 to Code Red Sublevel Two (2) with the information that Local Government Units (LGU's) outside the National Capital Region are advised to exercise sound discretion in suspending classes in their respective localities, without prejudice to a determination by the national government to suspend classes if the situation so warrants;

**WHEREAS**, for purposes of having a stringent social distancing measure, suspension of classes is inevitable in support to fight against COVID 19 Pandemic;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution adopting Executive Order No. 14-2020 issued by the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon ordering the Suspension of Classes in all Levels of Public and Private Schools in the Province of Sorsogon for a Period of Thirty (30) days beginning March 16, 2020 up to April 15, 2020;

**NOW THEREFORE**, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Rebecca D. Aquino**, resolve as it is hereby resolved to adopt Executive Order No. 14-2020 issued by the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon ordering the Suspension of Classes in all Levels of Public and Private Schools in the Province of Sorsogon for a Period of Thirty (30) days beginning March 16, 2020 up to April 15, 2020;

**RESOLVED FURTHER**, that Executive Order No. 14-2020 issued by the Hon. Joseph Francis G. Escudero, Governor, Province of Sorsogon shall be an integral part of this resolution;

**RESOLVED FINALLY** that copies of this resolution be furnished to all concerned for their information and guidance;
