RESOLUTION ADOPTING EXECUTIVE ORDER NO. 18-2020 ISSUED BY THE HON. FRANCIS JOSEPH G. ESCUDERO, GOVERNOR, PROVINCE OF SORSOGON DIRECTING ALL HEALTH PERSONNEL OF THE PROVINCE OF SORSOGON AS WELL AS THOSE OF LOCAL GOVERNMENT UNITS (LGU'S) WITHIN THE PROVINCE TO SHIFT FROM A CONTAINMENT STRATEGY TO A MITIGATION STRATEGY BY IDENTIFYING, MONITORING AND FOCUSING ON SECTORS AND PERSONS WHO ARE MOST VULNERABLE TO THE WORST EFFECTS OF COVID 19 AND FOR OTHER PURPOSES.

WHEREAS, on March 16, 2020, the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon issued Executive Order No. 18-2020 directing all Health Personnel of the Province of Sorsogon as well as those of Local Government Units (LGU's) within the Province to shift from a containment strategy to a mitigation strategy by identifying, monitoring and focusing on Sectors and Persons who are most vulnerable to the Worst Effects of COVID 19 and for other purposes;

WHEREAS, the herein Executive Order of the Governor is in consonance with the Proclamation No. 922 dated March 08, 2020 issued by His Excellency Rodrigo Roa Duterte, President, Republic of the Philippines declaring a State of Public Health Emergency throughout the Philippines due to COVID 19 and the imposition of additional measures to ensure the safety of the general public and lessen the possibility of spread of said disease;

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Disease also issued Resolution No. 11, series of 2020 dated March 12, 2020 raising the Code Alert System for COVID-19 to Code Red Sublevel Two (2);

WHEREAS, the shift from a containment strategy to a mitigation strategy by identifying, monitoring and focusing on Sectors and Persons who are most vulnerable to the Worst Effects of COVID 19 is among the effective way to protect the interest of general populace;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution adopting Executive Order no. 18-2020 issued by the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon directing all Health Personnel of the Province of Sorsogon as well as those of Local Government Units (LGU's) within the Province to shift from a containment strategy to a mitigation strategy by identifying, monitoring and focusing on Sectors and Persons who are most vulnerable to the Worst Effects of COVID 19 and for other purposes;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Rebecca D. Aquino**, resolve as it is hereby resolved to adopt Executive Order no. 17-2020 issued by the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon directing all Health Personnel of the Province of Sorsogon as well as those of Local Government Units (LGU's) within the Province to shift from a containment strategy to a mitigation strategy by identifying, monitoring and focusing on Sectors and Persons who are most vulnerable to the Worst Effects of COVID 19 and for other purposes;

RESOLVED FURTHER, that Executive Order No. 18-2020 issued by the Hon. Joseph Francis G. Escudero, Governor, Province of Sorsogon shall be an integral part of this resolution;

RESOLVED FINALLY that copies of this resolution be furnished to all concerned for their information and guidance;
