RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO EXECUTE A DEED OF CONDITIONAL DONATION COVERING A 400 SQUARE METER PORTION OF LOT 1 SITUATED AT BARANGAY POBLACION, BACON DISTRICT, SORSOGON CITY DULY COVERED BY TAX DECLARATION NO. 2011-01-0013-001372 IN FAVOR OF THE BUREAU OF FIRE PROTECTION, SORSOGON CITY FIRE STATION AS REPRESENTED BY THE ACTING CITY FIRE MARSHAL, SINSP. ERIC A. CARAMOAN

WHEREAS, among the items deliberated during the August 29, 2019 Regular Session of the 7th City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP dated July 29, 2019 requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to execute a Deed of Conditional Donation in favor of the Bureau of Fire Protection (BFP) represented by its Regional Director S/Supt. Manuel M. Manuel relative to the parcel of land under Tax Declaration

No. 2011-01-0013-001372 situated at Poblacion, Bacon District, Sorsogon City intended for the construction of the Bureau Of Fire Protection (BFP) Bacon District Sub-Office;

WHEREAS, the committees on Government Properties and Land Use, Urban Planning and Housing conducted joint committee hearing for the purpose therein find the importance of the request being valid and meritorious and thereby recommended for its approval in the plenary in session;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, **enhance economic prosperity and social justice**, maintain peace and order and **preserve the comfort and convenience of their inhabitants**;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to execute a Deed of Conditional Donation covering a 400 Square Meter portion of Lot 1 situated at Barangay Poblacion, Bacon District, Sorsogon City duly covered by Tax Declaration No. 2011-01-0013-001372 in favor of the Bureau of Fire Protection, Sorsogon City Fire Station as represented by the Acting City Fire Marshal, Sinsp. Eric A. Caramoan;
