RESOLUTION ADOPTING PROVINCIAL ORDINANCE NO. 19-2020 DATED MARCH 23, 2020 ENTITLED “AN ORDINANCE SETTING A NEW TWENTY-FOUR (24) HOUR CURFEW AGAINST MINORS AGED 15 YEARS AND BELOW WITHIN THE PROVINCE OF SORSOGON PURSUANT TO THE ENHANCED COMMUNITY QUARANTINE IN A BID TO PREVENT THE SPREAD OF CORONAVIRUS IN THE COUNTRY.

WHEREAS, on March 23, 2020, the 10th Provincial Board conducted its 39th Regular Session and approved among others the aforementioned Provincial Ordinance No. 19-2020;

WHEREAS, as authored by Hon. Edmundo A. Atutubo, Provincial Board Member, 1st Congressional District of the Province, said provincial ordinance objectives are as follows in light of the COVID 19 Pandemic globally affecting humanity;

1. Said Provincial Ordinance is in consonance with Executive Orders No. 13-2020 and 14-202 issued by Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon prescribing the Guidelines on the management of COVID 19, consistent with the Department of Health (DOH) protocols which include among others general preventive measures such as social distancing, class suspension and other risk mitigating measures and containment measures regarding community level transmission;
2. That said Provincial Ordinance would practically deter minors from roaming around socializing 24/7 thereby protecting our youths from health risk brought by COVID 19 Pandemic;
3. Said Provincial Ordinance is also anchored on updated official health bulletins issued by the Department of Health (DOH) wherein, COVID 19 selects no age and gender thereby threatening public health and safety.

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution adopting Provincial Ordinance No. 19-2020 dated March 23, 2020 entitled “An ordinance setting a New Twenty-Four (24) Hour Curfew against minors aged 15 years and below within the Province of Sorsogon pursuant to the Enhanced Community Quarantine in a Bid to prevent the spread of Coronavirus in the country”;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Rebecca D. Aquino**, resolve as it is hereby resolved to adopt Provincial Ordinance No. 19-2020 dated March 23, 2020 entitled “An ordinance setting a New Twenty-Four (24) Hour Curfew against minors aged 15 years and below within the Province of Sorsogon pursuant to the Enhanced Community Quarantine in a Bid to prevent the spread of Coronavirus in the country”;

RESOLVED FURTHER, that Provincial Ordinance No. 19-2020 dated March 23, 2020 entitled “An ordinance setting a New Twenty-Four (24) Hour Curfew against minors aged 15 years and below within the Province of Sorsogon pursuant to the Enhanced Community Quarantine in a Bid to prevent the spread of coronavirus in the country” shall be an integral part of this resolution;
