RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO OPEN A TRUST ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES (LBP)-SORSOGON BRANCH INTENDED FOR THE TRANSFER OF RESERVED FUNDS IN RELATION WITH THE OPERATION OF THE CAWAYAN MINI HYDRO-ELECTRIC PLANT.

WHEREAS, on March 09, 2020, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City and Members of the 7th City Council respectfully requesting for the passage of a resolution authorizing the local chief executive to open a Trust Account with the Land Bank of the Philippines (LBP)-Sorsogon Branch in relation with the operation of the Cawayan Mini Hydro-Electric Plant;

WHEREAS, aforementioned letter of the local chief is in cognizance of the letter from the Department of Energy (DOE) dated January 27, 2020 requesting for the submission of Bank Certificates to Facilitate Fund Transfer in accordance with DC2018-08-0021 and DO2019-01-0001;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to open a Trust Account with the Land Bank of the Philippines (LBP)-Sorsogon Branch in relation with the operation of the Cawayan Mini Hydro-Electric Plant;


