**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) / MEMORANDUM OF UNDERSTANDING (MOU) WITH THE PHILIPPINE NATIONAL POLICE (PNP) 1<sup>ST</sup> SORSOGON PROVINCIAL MOBILE FORCE COMPANY REPRESENTED BY ITS FORCE COMMANDER P/LTCOL. VIRGILIO O. OLALIA, JR., RELATIVE TO THE IMPLEMENTATION OF PROJECT MAGILAS SCHOLARS**

**WHEREAS**, among the items deliberated during the September 3, 2019 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) / Memorandum of Understanding (MOU) with the Philippine National Police (PNP) 1<sup>st</sup> Sorsogon Provincial Mobile Force Company represented by its Force Commander P/LTCOL. Virgilio O. Olalia, Jr., relative to the implementation of Project Magilas Scholars;

**WHEREAS**, Magandang Kinabukasang Adhikain na Gagabay para Insurhensya'y Labanan at Aktibong Sugpuin ng Sambayanan (Oplan Magilas) is a project of the 1<sup>st</sup> Sorsogon Provincial Mobile Force Company in the City of Sorsogon geared on further strengthening corroborative effort by and between the local government of Sorsogon and the PNP towards the effective delivery of basic services;

**WHEREAS**, the project which started sometime in 2017 has identified sixteen (16) secondary students residing at Barangay Marinas, East District, Sorsogon City and enrolled at Abuyog National High School wherein financial requirements for school curricular activities, sports activities, health care including school supplies of the identified students are being shouldered by Oplan Magilas Project;

**WHEREAS**, attached thereto is the draft Memorandum of Agreement (MOA) for perusal of the August Body;

**WHEREAS**, Committee on Laws, Justice and Human Rights conducted Committee hearing for the purpose therein revealed the noble intent and unique approach for the betterment of the city thereby recommending the passage of a resolution and extending support for the pursuance of this endeavor;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E.
