RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR TO REINSTALL “TIMBANGAN NG BAYAN” WITHIN THE VICINITY OF BACON PUBLIC MARKET, BACON DISTRICT, SORSOGON CITY

WHEREAS, there are numerous requests from the residents of Bacon District-Sorsogon City for the reinstallation of “Timbangan ng Bayan” in Bacon Public Market;

WHEREAS, the weighing scale that was previously installed in Bacon Public Market and served as the “Timbangan ng Bayan” could no longer be found or located;

WHEREAS, “Timbangan ng Bayan” is the only protection of the general public against unscrupulous or deceitful conducts of some vendors in the public market;

WHEREAS, there is a need for immediate reinstallation of the said “Timbangan ng Bayan” to provide the public a reliable, sealed and calibrated weighing scale/s so that

the hard earned money of every individual customer is valued and accorded with protection at all times;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, **enhance economic prosperity and social justice**, maintain peace and order and **preserve the comfort and convenience of their inhabitants**;
