RESOLUTION ADOPTING RESOLUTION NO. 01, SERIES OF 2020 OF THE CITY DEVELOPMENT COUNCIL (CDC) HELD LAST MARCH 9, 2020 AT THE SANGGUNIANG PANLUNGSOD SESSION HALL, ENTITLED “ RESOLUTION APPROVING THE REPROGRAMMING/ REALIGNMENT OF THE CY 2019 20% DEVELOPMENT FUND OF THE CITY OF SORSOGON IN THE AMOUNT OF FOUR MILLION TWO HUNDRED EIGHTY FIVE THOUSAND SIX HUNDRED FIFTY EIGHT PESOS AND 16/100 (P4,285,658.16)”.
