RESOLUTION RESPECTFULLY REQUESTING ALL GOVERNMENT AND PRIVATE FINANCIAL INSTITUTIONS TO DEFER PAYMENT OF MONTHLY AMORTIZATION WITHOUT SURCHARGES, PENALTIES AND INTEREST FOR AT LEAST ONE MONTH IN RELATION TO LOANS AND CREDIT CARDS OF CITY OFFICIALS AND EMPLOYEES WHILE UNDER THE ENHANCED COMMUNITY QUARANTINE.

WHEREAS, the threat on health and life of COVID 19 is now being felt by nations hardly hit by this pandemic;

WHEREAS, among those countries is the Philippines where at present drastic increase in cases of COVID 19 have been recorded, thus the measures undertaken among others are Enhanced Community Quarantine and Social Distancing;

WHEREAS, these measures would naturally affect the economic and financial capability of constituents to include City Officials and Employees;

WHEREAS, following the principle of collective compassion, good heart and consideration among our fellowmen, thus this resolution;

NOW THEREFORE, on motion of City Councilor Joven G. Laura, unanimously approved, resolve as it is hereby resolved to respectfully request all Government and Private Financial Institutions to defer payment of Monthly Amortization without surcharges, penalties and Interest in relation to Loans and Credit Cards of City Officials and Employees while under the Enhanced Community Quarantine;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance with the information that respective government and private financial lending institutions may offer other remedies or financial reliefs for at least one month that would definitely inure to the benefit patrons in this time of crisis.
