**RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE HON. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE V REPRESENTED BY MR. ARNEL B. GARCIA, REGIONAL DIRECTOR RELATIVE TO THE SOCIAL AMELIORATION PROGRAM.**

**WHEREAS, on April 06, 2020 Special Session of the 7<sup>th</sup> City Council, the august body approved Resolution No. 097, series of 2020 entitled “RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE NO. V REPRESENTED BY ARNEL B. GARCIA, REGIONAL DIRECTOR RELATIVE TO THE SOCIAL AMELIORATION PROGRAM.”;**

**WHEREAS**, said resolution is the immediate response of the 7<sup>th</sup> City Council in relation to April 03, 2020 letter request of the local chief executive requesting for an authority to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development, Regional Office V represented by Mr. Arnel Garcia in relation to the implementation of the Social Amelioration Program;

**WHEREAS**, considering the urgency of the matter and knowing that such would require extraordinary measures and in consonance with the provisions of RA 11469 otherwise known as the "Bayanihan to Heal as One Act of 2020", the 7<sup>th</sup> City Council deemed it necessary to further ratify the Memorandum of Agreement entered into by and between the City Government of Sorsogon represented by the Hon. Ma. Ester E. Hamor, City Mayor and Mr. Arnel Garcia, Regional Director, Department of Social Welfare and Development, Regional Office V;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution Ratifying the Memorandum of Agreement entered into by and between the Hon. Ester E. Hamor, City Mayor, Sorsogon City and the Department of Social Welfare and Development (DSWD) Regional Office V represented by Mr. Arnel B. Garcia, Regional Director relative to the Social Amelioration Program ;

**NOW THEREFORE**, on incidental motion of **City Councilor Franco Eric O. Ravanilla**, unanimously approved, resolve as it is hereby resolved to ratify the Memorandum of Agreement entered into by and between the Hon. Ester E.
