**RESOLUTION ENDORSING TO THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) CENTRAL OFFICE AND SAN MIGUEL CORPORATION THE REQUEST OF THE CITY GOVERNMENT OF SORSOGON FOR THE PROVISION OF FOOD PACKS INTENDED FOR DISTRIBUTION TO ALL HOUSEHOLDS IN THE CITY OF SORSOGON.**

**WHEREAS**, on April 13, 2020, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda and the members of the 7<sup>th</sup> City Council respectfully requested for the passage of a resolution endorsing to the Department of Social Welfare and Development-Central Office and San Miguel Corporation the request of the City Government of Sorsogon for the provision of Food Packs intended for distribution to all households in the City of Sorsogon;

**WHEREAS**, this is in line with the global threat of COVID 19 disrupting our economy and financial capability of residents, the declaration of Enhanced Community Quarantine

in an effort to curve incidence of COVID 19 positive cases through social distancing thus hindering local residents to work and sustain their daily family needs;

**WHEREAS**, the City Government of Sorsogon has appropriated considerable amount for the provision of assistance to the local populace, facilitated distribution of food packs to all households notwithstanding their respective social status and other mitigating local initiatives relevant to COVID 19 Pandemic;

**WHEREAS**, the City Government of Sorsogon stands firm on its fight against COVID 19 and to pursue aforementioned endeavour, however, the local government unit is constrained especially in the distribution of additional food packs, thus this resolution;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution endorsing to the Department of Social Welfare and Development (DSWD) Central Office and San Miguel Corporation the request of the City Government of Sorsogon for the Provision of Food Packs intended for Distribution to All Households in the City of Sorsogon;


