RESOLUTION RESPECTFULLY REQUESTING MOTORCYCLE DEALERS OPERATING IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON TO ALLOW MORATORIUM ON MONTHLY INSTALLMENT OF MOTORCYCLES UNDER FINANCING SCHEME PENDING COVID 19 PANDEMIC IN CONSONANCE WITH THE PROVISION OF REPUBLIC ACT 11469 OTHERWISE KNOWN AS THE "BAYANIHAN TO HEAL AS ONE ACT"

WHEREAS, economy among others was greatly devastated by COVID 19 Pandemic in view of the application of Enhanced Community Quarantine and Social Distancing as part of the effective measure to address the aforementioned global threat;

WHEREAS, among those seriously affected are individuals who have availed of the Motorcycle Financing Scheme offered by Motorcycle Dealers be it used for private purpose or for their source of income;

WHEREAS, lately, government and private financial institutions manifested their cooperation and human understanding on the present predicament by providing moratorium of monthly instalment of loan windows availed by their stakeholders amid COVID 19;

WHEREAS, this may be true to those in government and private employees allowed and/or qualified to avail of loan windows offered of government and private institutions, however, this does not include individuals who have existing motorcycles availed under Financing Scheme of Motorcycle Scheme, thus this resolution;

WHEREAS, for purposes of this resolution, the idea is to allow at least two (2) months moratorium on monthly instalments of motorcycle availed thru financing without penalties and surcharges;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution respectfully requesting Motorcycle Dealers operating in the territorial jurisdiction of the City of Sorsogon to allow moratorium on monthly installment of motorcycles under financing scheme pending Covid 19 Pandemic in consonance with the provisions of Republic Act 11469 otherwise known as the "Bayanihan to Heal As One Act";

NOW THEREFORE, on motion of City Councilor Franco Eric O. Ravanilla, duloy seconded by City Councilor Joven G. Laura, resolve as it is hereby resolved to request Motorcycle Dealers operating in the Territorial Jurisdiction of the City of Sorsogon to allow Moratorium on Monthly Instalment of Motorcycles Under Financing Scheme Pending Covid 19 Pandemic in Consonance with the Provisions of Republic Act 11469 otherwise known as the "Bayanihan to Heal As One Act";

RESOLVED FURTHER, that copies of this resolution be furnished to all Motorcycle Dealers in the territorial jurisdiction of Sorsogon City with an appeal for their positive and most favourable action on this matter.
