RESOLUTION AUTHORIZING THE GRANT OF GASOLINE SUBSIDY TO TRICYCLE TRANSPORT SECTOR OPERATING IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON.

**WHEREAS,** amid COVID 19 Pandemic, precautionary measures have been instituted by local government units in response to prevent the spread to their respective localities;

**WHEREAS,** the Tricycle Transport Community was among the heavily affected sector in view of the Enhanced Community Quarantine imposed upon the entire Luzon wherein Social Distancing is strictly implemented;

**WHEREAS,** following assessment of provinces by appropriate national government agencies in relation to COVID 19 Pandemic, the Province of Sorsogon was downgraded to General Community Quarantine from Enhanced Community Quarantine;

**WHEREAS,** recognizing the necessity of Tricycle Transport Operations while under the General Community Quarantine effective May 1, 2020, there is a need to at least allow a minimal presence and operation of tricycle for hire being the usual mode of transportation and conveyance of our local populace;

**WHEREAS,** be it known for the record however that Social Distancing is still strictly implemented, for this reason, guidelines shall be established as to the number of authorized tricycle passenger per trip and scheduling of authorized tricycle operations;

**WHEREAS,** the City Government of Sorsogon, through the Sangguniang Panlungsod understands the plight of the Tricycle Transport Sector and for this purpose, two (2) liters of gasoline subsidy shall be granted to those authorized to operate tricycle operations depending on their schedule as provided;

**WHEREAS,** following the provisions of General Welfare Clause under Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991, the necessity to authorize minimal number of tricycle operations is justified for purposes of the welfare and convenience of the general riding public;

WHEREAS, as regards to the scheme to be adopted in relation to the authorized minimal presence and operations of tricycles for hire and authorized passenger per trip effective May 1-10, 2020, the Committee on Transportation and the Committee on Franchise of the Sangguniang Panlungsod shall immediately convene and shall submit their Joint Recommendations not later April 30, 2020;

**WHEREAS,** foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the grant of gasoline subsidy to Tricycle Transport Sector operating in the territorial jurisdiction of the City of Sorsogon;

**NOW THEREFORE,** on motion of **City Councilor Franco Eric O. Ravanilla,** duly seconded by **City Councilor Joven G. Laura,** resolve as it is hereby resolved to authorize the grant of gasoline subsidy to Tricycle Transport Sector operating in the territorial jurisdiction of the City of Sorsogon;

**RESOLVED FURTHER,** that copies of this resolution be furnished to all concerned for their information and guidance.
