RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (PENRO) REPRESENTED BY ATTY. RONNEL C. SOPSOP, ASSISTANT REGIONAL DIRECTOR FOR THE PURPOSE OF EXPEDITING THE ISSUANCE OF SPECIAL PATENTS IN THE NAME OF THE CITY GOVERNMENT OF SORSOGON FOR THE NUMEROUS PARCELS OF LAND IT OWNS OVER ITS THREE DISTRICTS.

WHEREAS, among the items deliberated during the September 3, 2019 Regular Session of the 7th City Council is the letter-request for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Provincial Environment and Natural Resources Office (PENRO) represented by Atty. Ronnel C. Sopsop, Assistant Regional Director for the purpose of expediting the issuance of special patents in the name of the City Government of Sorsogon for the numerous parcels of land it owns within the three districts;

WHEREAS, the City of Sorsogon, in its proprietary and governmental capacity, owns numerous parcels of land within its three (3) districts; i.e. Bacon District, East District and West District, hitherto unregistered under the Torrens System;

WHEREAS, R.A. 10023 provides a most expeditious way of having the proprietary and governmental lands owned by the City of Sorsogon to be registered under the Torrens System, as a means of providing basic services and infrastructural support to the City's constituents in accordance with Section 17 of the Local Government Code of 1991, especially now that DENR is implementing the policy of partnering with local government units (LGU's) in the conduct of land titling in order to fast track the processing and issuance of land titles over inalienable and disposable lands;

WHEREAS, an Executive Order has been issued for the creation of a Technical Working Group tasked with the preparation of a detailed inventory of all proprietary lands of the City of Sorsogon, determining their exact location and naming the persons holding the same;

WHEREAS, attached thereto is the draft Memorandum of Agreement (MOA) and Executive Order for perusal of the August Body;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Provincial Environment and Natural Resources Office (PENRO) represented by Atty. Ronnel C. Sopsop, Assistant Regional Director for the purpose of expediting the issuance of special patents in the name of the City Government of Sorsogon for the numerous parcels of land it owns over its three districts;


NOW THEREFORE, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Provincial Environment and Natural Resources Office (PENRO) represented by Atty. Ronnel C. Sopsop, Assistant Regional Director for the purpose of expediting the issuance of special patents in the name of the City Government of Sorsogon for the numerous parcels of land it owns over its three districts;

RESOLVED FURTHER, that the Memorandum of Agreement entered into by the parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Office of the Secretary to the Sangguniang Panlungsod for records and archive purposes;


RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
