RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO GRANT ADDITIONAL AID TO SIXTY FOUR (64) BARANGAYS OF THE CITY OF SORSOGON INTENDED FOR BARANGAY SECRETARIES AND BARANGAY TREASURERS.

**WHEREAS**, in consonance with national directives to fight the spread of COVID 19 Pandemic in their respective localities, local government units, provinces, cities, municipalities and barangays instituted measures to protect their local residents from this deadly disease;

**WHEREAS,** among those who step forward and exposed themselves while others stayed at home are Barangay Treasurers and Barangay Secretaries;

**WHEREAS**, this appointive barangay officials may have opted to stay at home considering the declaration of Enhanced Community Quarantine in the entire Luzon by way of Social Distancing, instead, they choose to be present and attend to their barangay

duties and functions such as but not limited to distribution of food packs from the city and barangay, assisted in the implementation of Social Amelioration Program of the national government and such other undertaking without overtime pay or additional benefits;

**WHEREAS**, of this trying times, the Hon. Ma. Ester Hamor, City Mayor, Sorsogon City admired the unselfish contribution of our Barangay Secretaries and Barangay Treasurer and decided to grant additional barangay aide intended to this barangay personnel;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to Grant Additional Aid to Sixty Four (64) Barangays of the City of Sorsogon Intended for Barangay Secretaries and Barangay Treasurers;
