RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO SUSPEND COLLECTION OF RENTALS IN ALL PROPERTIES OF THE CITY GOVERNMENT OF SORSOGON LEASED TO PRIVATE PERSONS AND LOCAL BUSINESSMEN UNTIL THE GENERAL COMMUNITY QUARANTINE IS LIFTED.

**WHEREAS**, in consonance with national directives to fight the spread of COVID 19 Pandemic in their respective localities, local government units, provinces, cities, municipalities and barangays instituted measures to protect their local residents from this deadly disease;

**WHEREAS,** local business operations to name is among those greatly devastated by this dreadful disease being ordered to stop operations in view of the declaration of Enhanced Community Quarantine in the entire Luzon;

**WHEREAS**, the City Government of Sorsogon have properties leased to private persons and local businessmen who ceased business operations for purposes of protecting the interest of their employees and in compliance of the directive issued by the national government;

**WHEREAS**, in cognizance of the plight of the business enterprises affected by this trying times, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter dated April 28, 2020 addressed to the Hon. Eric C. Dioneda, City Vice Mayor, Sorsogon City and Members of the City Council requesting for the aforementioned legislation;

**WHEREAS,** foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to Suspend Collection of Rentals in all Properties of the City Government of Sorsogon Leased to Private Persons and Local Businessmen until the General Community Quarantine is lifted;

NOW THEREFORE, on motion of City Councilor Joven G. Laura, duly seconded by City Councilor Erwin J. Duana, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to Suspend Collection of Rentals in all Properties of the City Government of Sorsogon Leased to Private Persons and Local Businessmen until the General Community Quarantine is lifted;
