RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE SENIOR HIGH SCHOOLS WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON RELATIVE TO THE WORK IMMERSION PARTNERSHIP AS PART OF THE K-12 PROGRAM

WHEREAS, on September 3, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, wrote a letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, SP Secretary respectfully requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, to enter into a Memorandum of Agreement (MOA) with the senior high schools within the territorial jurisdiction of the City of Sorsogon relative to the Work Immersion Partnership as part of the K-12 Program;

WHEREAS, the Department of Education has introduced the K-12 basic education reform program that includes Senior High School (SHS) with the major objective of ensuring that the graduates of basic education are ready for employment, entrepreneurship and higher learning;

WHEREAS, the DepEd believes that for the effective delivery of SHS instruction, there is aimed for school-industry partnership that will provide the school necessary expertise and venue for practical, on-the-job, enterprise-based training for SHS learners;

WHEREAS, attached to the letter request is a Pro-Forma Memorandum of Agreement (MOA) for the perusal of the 7th City Council;

WHEREAS, the Local Government Unit fully supports the provision of quality education which intends to perfect the agreement with the Senior High Schools and commits to the obligations set forth in the Memorandum of Agreement;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 6th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, to enter into a Memorandum of Agreement (MOA) with the senior high schools within the territorial jurisdiction of the City of Sorsogon relative to the Work Immersion Partnership as part of the K-12 Program;

NOW THEREFORE, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Fernando David H. Duran, III**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, to enter into a Memorandum of Agreement (MOA) with the senior high schools within the territorial jurisdiction of the City of Sorsogon relative to the Work Immersion Partnership as part of the K-12 Program;
