RESOLUTION ADOPTING EXECUTIVE ORDER NO. 36-2020 ISSUED BY THE HON. FRANCIS JOSEPH G. ESCUDERO, GOVERNOR, PROVINCE OF SORSOGON PROVIDING FOR GUIDELINES IN THE IMPLEMENTATION OF A CONTROL SYSTEM OF MANDATORY QUARANTINING AND CHECKPOINTS UNDER THE GENERAL COMMUNITY QUARANTINE (GCQ) IN THE PROVINCE OF SORSOGON AND FOR OTHER PURPOSES.

WHEREAS, on April 27, 2020, the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon issued Executive Order No. 36-2020 Providing for Guidelines in the Implementation of a Control System of Mandatory Quarantining and Checkpoints under the General Community Quarantine (GCQ) in the Province of Sorsogon and for other purposes;

WHEREAS, the herein Executive Order of the Governor is in consonance with the approval by PRRD the recommendation of the Inter-Agency Task Force (IATF) classifying

the Province of Sorsogon as a “Low-Risk Area” thereby placing the province under a “Low” General Community Quarantine;

WHEREAS, the Executive Order by the Governor also includes the continuing need to provide guidelines, in accordance with IATF policies and above all to keep Sorsogonans safe and the Province COVID 19 Free;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution adopting Executive Order No. 36-2020 issued by the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon Providing for Guidelines in the Implementation of a Control System of Mandatory Quarantining and Checkpoints under the General Community Quarantine (GCQ) in the Province of Sorsogon and for other purposes;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Fernando David H. Duran, III**, resolve as it is hereby resolved to adopt Executive Order no. 19-2020 issued by the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon Providing for Guidelines in the Implementation of a Control System of Mandatory Quarantining and Checkpoints under the General Community Quarantine (GCQ) in the Province of Sorsogon and for other purposes ;

RESOLVED FURTHER, that Executive Order No. 36-2020 issued by the Hon. Joseph Francis G. Escudero, Governor, Province of Sorsogon shall be an integral part of this resolution;
