RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF INCONTRADA AT THE SORSOGON CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the September 10, 2019 Regular Session of the 7th City Council is the letter-request from Mr. Allan Jeresano, Chief Tanod, Barangay Guinlajon, West District, Sorsogon City dated September 5, 2019 addressed to Hon. Eric Dioneda, City Vice Mayor requesting for derby permit at the Sorsogon Central Cockpit Arena located at Barangay Bibincahan, East District, Sorsogon City every Monday to Thursday from September 16 to 30, 2019;

WHEREAS, as reflected in the request, it is stated that portion of the proceeds will be donated to charitable institutions;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to identified charitable institutions in the City of Sorsogon and that the party shall faithfully comply therewith;

WHEREAS, pursuant to existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the city;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of incontrada at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

NOW THEREFORE, on motion of **Hon. Danilo A. Deladia**, duly seconded by **Hon. Fernando David H. Duran, III,** resolve as it is hereby resolved to approve and authorize the conduct of fincontrada at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

RESOLVED FURTHER, that fees and charges appurtenant thereto shall be paid to the City Treasurer's Office prior to the conduct of the activity;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
